# **Housing Supply Overview**

U.S. sales of new-residential homes fell for the first time in three months, sliding 0.3% month-over-month to a seasonally adjusted annual rate of 662,000 units, according to the Census Bureau, as the previous month's sales pace was revised up to 664,000 units from 661,000 units. Despite the decline, new-home sales were up 5.9% compared to the same time last year. The median new-home sales price also softened, dropping 7.6% year-over-year to \$400,500 as of last measure. For the 12-month period spanning April 2023 through March 2024, Pending Sales in the Greenwood Association of REALTORS® region were down 9.5 percent overall. The price range with the largest pending sales gain was the \$1,000,001 and Above range, where sales went up 120.0 percent.

The overall Median Sales Price improved 9.1 percent to \$240,000. The property type with the largest gain was the Condos segment, where prices improved 19.3 percent to \$173,000. The price range that tended to sell the quickest was the \$150,000 and Below range at 71 days. The price range that tended to sell the slowest was the \$1,000,001 and Above range at 141 days.

Market-wide, inventory levels increased 30.1 percent. The property type with the largest gain was the Condos segment, where the number of properties for sale improved 33.3 percent. That amounts to 3.4 months of inventory for Single-Family Homes and 2.9 months of inventory for Condos.



A count of properties on which offers have been accepted. Based on a rolling 12-month total.






#### **Closed Sales**

A count of the actual sales that closed. Based on a rolling 12-month total.






## **Days On Market Until Sale**

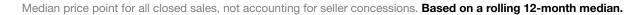
Average number of days between when a property is listed and when an offer is accepted.

Based on a rolling 12-month average.





Percentage found when dividing a property's sales price by its last list price, then taking the average for all properties sold, not accounting for seller concessions.


